

Bogus Basin Ski Club Minutes October 2, 2012

The Business meeting was called to order: by President Rosie Rosco at 6:30 pm.

Treasurer's Report: Bob distributed the BBSC account transaction history summary for September 2012. Paul motioned to approve the Treasurer's report while Bonnie second and the Board approved.

New Business:

Season Passes: Kerry made a motion to raise the season pass cost from \$285 to \$300 and increase the price as Bogus raises their prices. Darryl second and the Board approved. BBSC season passes will be taken off Craig's List at this time. The Board will discuss this issue again at the December meeting and will review pass prices.

Marketing Meeting Report: Rosie gave the BBSC Board the new marketing plan. Pat stated Boise State may be able to do the marketing sign and he will check into it and order. Darryl will print some of the new marketing brochures for Oktoberfest. Rosie will send to Autosort and ask them to make 1,000 copies for future use.

Continuing Business:

Bardenay Tour: Pat stated he is planning the tour and will work with Will at IEE.

Activity Reports:

Champagne Brunch: Rosie's report showed who attended, expenditures, revenues and suggestions for next year. 67 attended the event and much less was spent from the last 2 years.

Shakespeare: Bonnie stated 11 attended.

Upcoming Activities:

Oktoberfest: Natalie reported it is this Friday and the cost is \$8 for members and \$12 for non-members. New members will pay \$25 membership and the event will be free. Equipment will be picked up and returned by Paul. Kerry will do the participant sign in at the door. Paul will get needed tables and equipment from storage. The BBQ will be delivered by Jeff and manned by Darryl. Pat will provide the music. Michael will donate food. Natalie stated she has a \$500 budget.

Greenwood's Promotional Event: Bonnie stated the event will be this Saturday from

11:00 am to 2:00pm October 6th. Bonnie requested volunteers to help. Greenwood's will supply the food and drinks.

Ski Swap: Rosie stated Jane needs volunteers for November 2nd, 3rd and 4th.

Warren Miller Movie: Rosie stated the movie will be November 15, 16, and 17. The committee consists of Larry, John Greenwood, Michael, Bob and Pat. Ruby volunteered previously to coordinate the volunteers and BBSC booth. But since she is out of town until November 1, Rosie will start the ball rolling. Michael stated John has not called yet to organize a meeting. John and Michael will meet next week to decide on movie marketing. Rosie asked for volunteers.

Holiday Party: Bonnie stated she is planning on using the Elks on Fairview for the December 15th party. We can rent the building for four hours for \$175. She stated the party is still in the planning stages.

Targhee Trip: Michael stated the Intermountain Ski Council trip will be February 21st-24th. He needs 42 participants. The cost will be \$395 including the bus from Boise. The Board approved Michael's request to advertise the trip at the Oktoberfest, at Greenwood's Promotional Event, other upcoming events and in the Mogul starting in November.

Tahoe Trip: Will be January 27th. 24 have made deposits with 6 interested. 40 are needed. The trip was approved at the last meeting.

Innsbruck Trip: Paul stated the trip will be in February of 2014. He would like 40 participants. Cost at this point is \$2138 which includes flight, hotel, breakfast, ground transportation, ski bus, etc. Optional trips will be made available. Pat moved to support and sanction the trip and Darryl second. The Board approved.

Sun Valley Trip: Paul presented his trip proposal. The dates are March 22,23, and 24. If there are 40 participants cost will be \$244 while if there are 30 participants the cost will be \$264. Paul is looking for someone to chair.

Argentina: Paul discussed the possibility of a late July ski trip to Argentina. He would need 15 people for the trip.

Other Business:

Crab Crack: Fred stated he has set the date for February 9, 2013 at the Gowen Field Officers Clubhouse.
